

Training for Legal Form Collection Change

We closed out 2023 with an email outlining our new legal form collection process. We hope that the changes result in fewer forms to collect and upload with built-in MIS defaults to ensure legal compliance. Below are answers to some common questions about the changes we have received from providers. Some recent questions we've received:

- Are insurance card copies required to be uploaded for reimbursement in 2024? At this
 time, insurance cards are not required for reimbursement. While not required, uploading
 copies of cards is very helpful to our insurance billing specialist to ensure that she has
 correct information to bill insurance companies. This saves everyone time in the long run
 for errors such as transposed numbers and other incorrect insurance plan
 information. Collecting insurance cards is highly encouraged for Diabetes Prevention
 Program classes.
- Will class participants receive a notification when their legal forms are
 expiring? Participants will receive a notice when their class forms have expired when they
 register for a new class. You will be able to view forms and dates on the class participant
 details page in the MIS.

This <u>handy forms chart</u> be found in the Juniper toolkit and can help you determine who needs to fill out which forms when. The first and last session form packets will be updated by 1/8/2024 with

some formatting changes for consistent layouts and titles. If you print and prepare first and last session form packets in batches, please wait until after 1/8/2024 to print them.

Powerful Tools for Caregivers Participant survey

Several providers have asked if the Powerful Tools for Caregivers (PTC) survey in the MIS is correct. The concern is that it is the same survey used in the Living Well series of classes, and it does not provide program specific information that some providers found useful. The survey in the MIS is the survey we are required to report for our ACL grants. You may collect additional surveys, but for our purposes you are not required to report those results to us. We contacted the national office for PTC, and this was their response regarding the surveys they require:

"Class Leaders receive evaluation forms in their materials zip drive once licensed. We do have it written into the curriculum for the leaders to provide the participants with an evaluation form at the end of week 1, with reminders for them to bring the evaluation form back each week so they can complete a weekly assessment. We do not require the evaluations to be reported back to PTC HQ at this time. Class Leaders are asked to report the number of enrolled participants (both at the start and conclusion of the six weeks), but that is an automated process, and the class leaders will receive that email from PTC HQ directly."

What is a Community Care Hub?

There has been a lot of buzz around community care hubs. They were mentioned in President Biden's Social Determinants of Health playbook that we shared last month. But what is a community care hub? A community care hub is another way to describe our Juniper network. Our friends from Healthy Living for ME, an organization in Maine that license the Juniper software platform, created this 2-minute video describing community care hubs. MIS Manual Update
