
## Medicare Rate Increase for DPP

The Medicare Diabetes Prevention Program (DPP) rates for G9886 and G9887 were formerly \$25, and G9880 was \$145. The new rate for G9886 and G9887 is \$26 and for G9880 is \$149. The rate for G9888 remains the same. This is a 4% increase for G9886 and G9887 and 2.7% increase for G9888. We are

adjusting our billing processes so that we can begin billing at these new rates right away. Medicare Sequestration Payment Reductions will continue to impact the rates.

#### **New in** 2025 Updated Payment Rates for MDPP Services

The payment rate for G9880, G9881, G9886, and G9887 has been increased to account for inflation
