We hope this change prevents or reduces signature errors where participants miss a key piece of information, like a signature date or printed name.

Key things to know:

- These new 2025 forms contain formatting changes only, no changes to legal language.

- Therefore, 2024 and 2025 legal forms are equally acceptable to use. So, if you printed a batch of 2024 legal forms for the year, you don't need to recycle them. You can use them up.
- I do encourage transitioning to the 2025 legal forms as you are able. We do believe these formatting changes will be helpful.
